## Hope in the Valley Equine Rescue and Sanctuary in Kansas is Verified by the Global Federation of Animal Sanctuaries

August 8, 2012 (Valley Center, KS) – The Global Federation of Animal Sanctuaries (GFAS), the only globally recognized organization providing standards for identifying legitimate animal sanctuaries, awarded Verified status to Hope in the Valley Equine Rescue and Sanctuary as of July 1, 2012.

Verification means that Hope in the Valley meets the criteria of a true equine sanctuary/rescue and is providing humane and responsible care of the animals. To be awarded Verified status, an organization must meet GFAS's rigorous and peer-reviewed animal care standards which are confirmed by a site visit and they must also adhere to a demanding set of ethical and operational principles.

"We are pleased to announce the verification of Hope in the Valley Equine Rescue and Sanctuary," said Jeannine Alexander, GFAS Deputy Director-Equine. "This organization not only provides quality care for a large number of homeless horses in Kansas, but they also are committed to educating their community about equine neglect and abuse." Ande Miller, Board President of Hope in the Valley, stated, "We, at Hope in the Valley Equine Rescue and Sanctuary, are grateful to GFAS for the opportunity to improve the care of our wonderful equine companions. We are proud to be able to say that we live up to the standards that these animals deserve. As a Verified facility, we will continue to make changes for the betterment of their care.
